



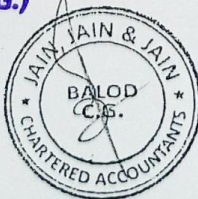
AUDITOR'S REPORT

 - B. In the case of receipts & payments account, of the receipts and payments of the agency for the year ended on 31st March 2024.


